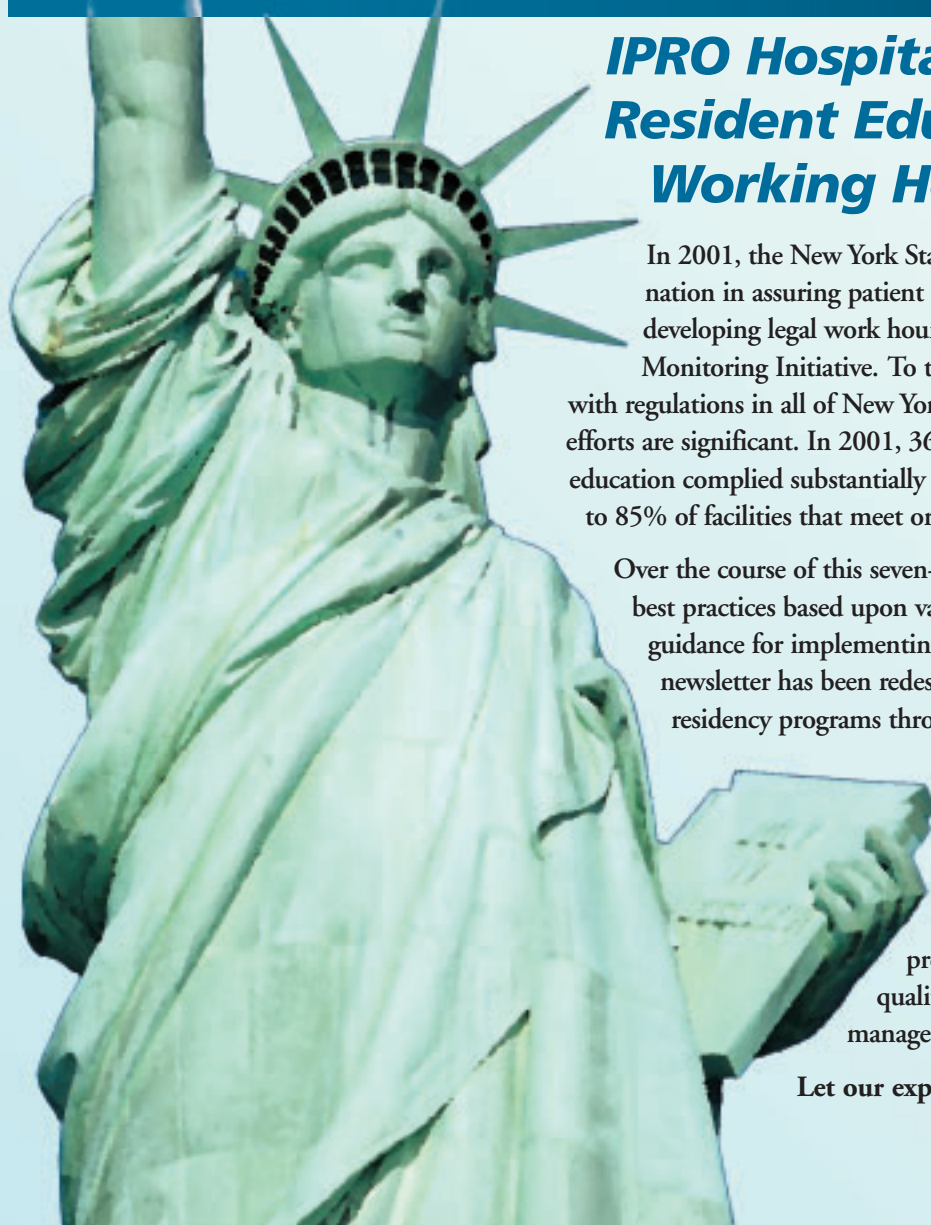
IPRO Hospital Compliance - Resident Education and Working Hour Oversight

In 2001, the New York State Department of Health (NYSDOH) led the nation in assuring patient safety, improving health care quality and developing legal work hour standards by launching the Resident Work Hour Monitoring Initiative. To that end, IPRO was selected to monitor compliance with regulations in all of New York State's teaching hospitals. The results of our efforts are significant. In 2001, 36% of the 120 institutions of advanced medical education complied substantially with the regulations; current compliance has risen to 85% of facilities that meet or surpass the standards set forth by NYSDOH.

Over the course of this seven-year contract, the experts at IPRO have developed best practices based upon vast experience and as such, can offer practical guidance for implementing work hour regulations. The *Resident Times* newsletter has been redesigned so we can share our knowledge with residency programs throughout New York State and across the country.

The members of IPRO's Hospital Compliance Team have diverse professional backgrounds, including skilled health care professionals; compliance professionals holding a certification in health care compliance; health care quality professionals holding certification in health care quality; legal professionals; and health information management professionals.

When a renowned teaching facility was found out of compliance with the ACGME work hour regulations and facing possible withdrawal of accreditation of its internal medicine residency program it turned to IPRO's Hospital Compliance Team for assistance. Responses to questions from the Graduate Medical Education Community

QUESTION:

How do programs provide resident education for the post-call resident?

ANSWER:

Many programs are posting videos of grand rounds and other mandatory academic conferences on their intranet, so post-call residents can view them as their schedules allow. In programs where formal attending rounds/am report or sign out is required, post-call residents present their patients first so they can leave within the allotted time (which in New York State is three hours).

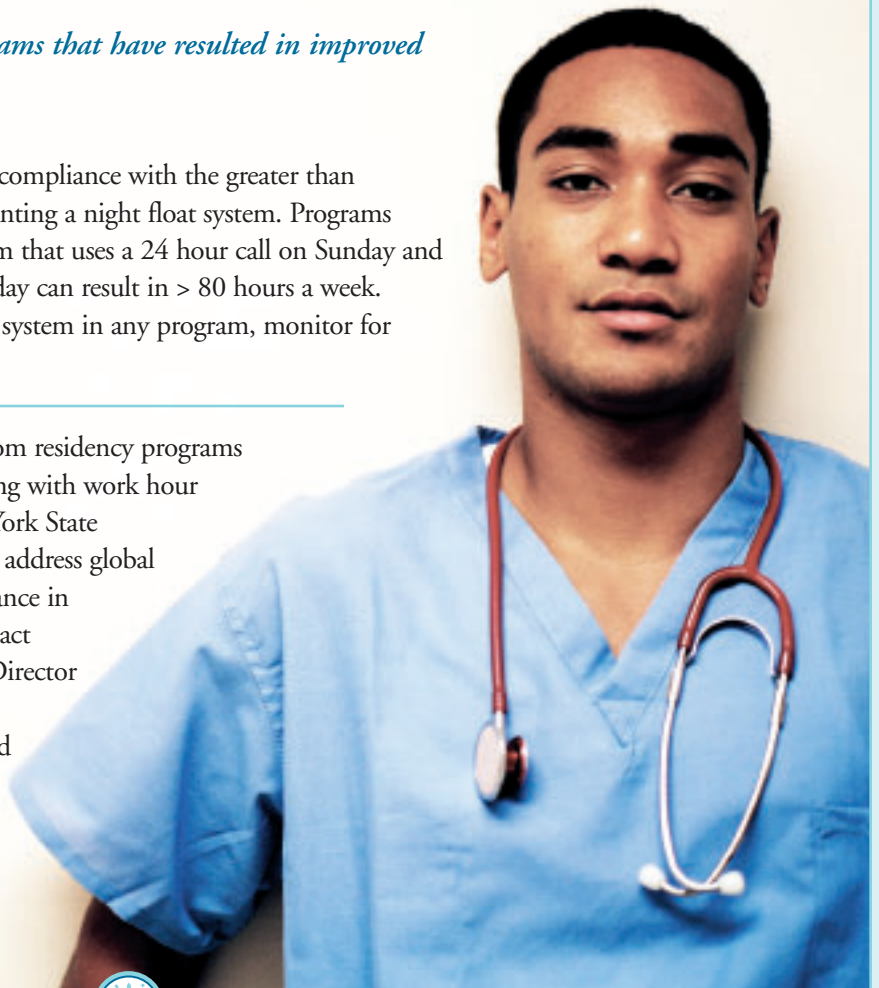
QUESTION:

What changes have been made in surgical programs that have resulted in improved compliance?

ANSWER:

Surgical programs of varying sizes reported improved compliance with the greater than 24 consecutive hours on call requirement by implementing a night float system. Programs should be cautioned, however, that a night float system that uses a 24 hour call on Sunday and then 12-14 hour night float shifts on Monday-Thursday can result in > 80 hours a week. A word to the wise: when implementing a night float system in any program, monitor for > 80 hours as well.

Questions such as these are received by our experts from residency programs looking for practical advice and guidance on complying with work hour regulations. While our responses are specific to New York State requirements, suggested approaches can be tailored to address global work hour mandates.
